

Raise The Barre Performing Arts
Company Contract 2023-2024

- **Tuition-** Tuition will be calculated by adding the totals of company costumes and competition fees together, then divided by a number of months determined by our company staff. This does not include monthly tuition.
- **Costumes-** Each costume is \$80 and will be broken down into 8 monthly payments, August- March.
- **Additional Costs-** Fees not included in the monthly breakdown include your team jacket, company staff fee, and private lessons.
- **Private Lessons-** Private lessons will be paid to each teacher before the private takes place via VENMO. If you fail to pay beforehand, the private will not happen. In addition, the student and teacher must sign in at the desk for the private.
- **Attendance-** Each student is allowed 5 absences each semester. If the student has more than 5 absences, they may be on probation/removed from competition team/pay for additional private-THIS INCLUDES YOUR CORE CLASSES AS WELL!
- **Competition-** Attendance for each competition is mandatory. It is important to also be there the week of practice before competition. Please note that once the fees are paid to attend the competition, if the dancer is unable to make the competition (due to illness, etc.) the fees are non-refundable. Fees will only be refunded if the ENTIRE competition is cancelled.
- **Dress Code-** All company dancers are required to wear all black clothing, hair securely pulled back, and the proper footwear for all of their classes. At competition, dancers will wear their company jackets or RTB shirt for all award ceremonies.
- **Hair and Make-up-** Parents will be responsible for their child's hair and make-up at each competition. The parents are also responsible for purchasing the make-up and hair tools required to achieve the look the teacher has set.
- **Class Requirements-** You MUST (except Hip-Hop) be enrolled in Ballet IN ADDITION to a recreational class in the style of the assigned routine (if you are in Company Lyrical, you must also be enrolled in a recreational Lyrical class + Ballet). Musical Theater is allowed to take Jazz. Company Hip Hop must also be enrolled in a recreational Hip Hop class. If there are schedule conflicts, please see your instructors on which classes they recommend.
- **Enforcement-** The directors/coaches reserve the right to make and enforce disciplinary decisions concerning any situation not covered in this contract. The directors/coaches reserve the right to interpret eligibility standing of every member of the group.
- **Behavior-** Dancers are representing Raise The Barre inside and outside of the studio. At competitions, we will treat everyone with kindness. Please be aware that your online presence will be representing us as well.
- **Payments-** Your account must be COMPLETELY clear **12/31**. If it is not, your child is to still attend their classes, however, they will not be able to actively participate. Also, if the account is not paid by **5/16**, your child will not participate in Recital. No fees will be refunded.
